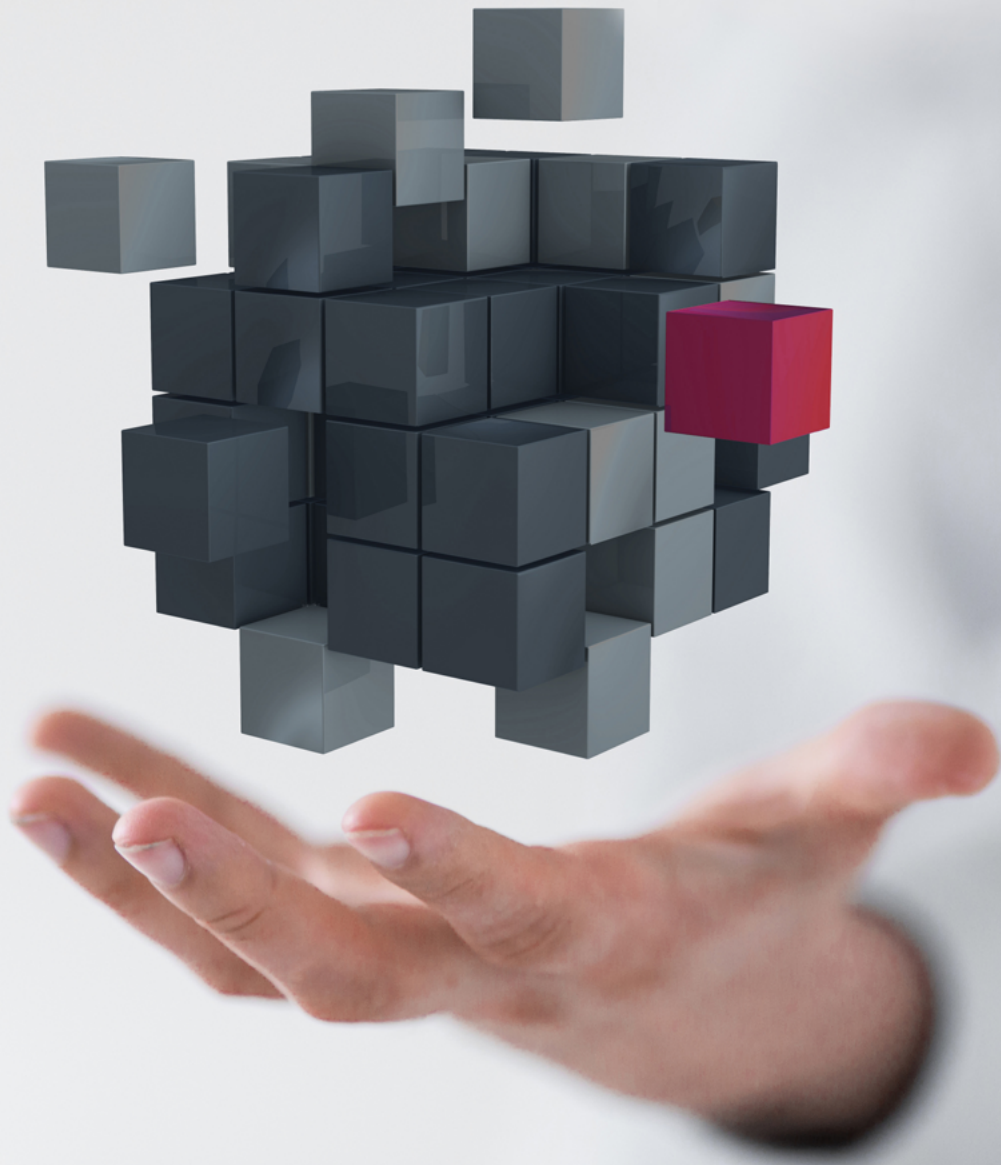

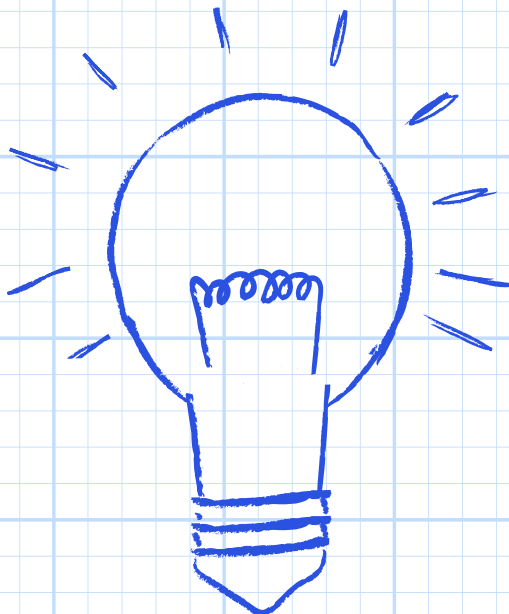
To be exact this means, for example:

Whether non-life or life insurance, the flexible msg.PIA complete solution can be used for all insurance-related processes, as well as in different lines of business and fields of insurance business.

End-to-end solution for all applications

From product design to contract and claim management, or even collection and disbursement, msg.PIA supports all processes an insurer performs. It also enables the management of all lines of business in both international, personal and industrial business and offers a wide range of standard processes “out of the box”, such as:

- New business
- Contract changes, including object changes, (automatic) tariff version changes, automatic indexations, bonus/penalty calculations and index increases
- Profit sharing and funds movements
- Shelving
- Termination
- Cancellation
- Etc.

Other transactions, such as bonus/penalty, index-linking, subsequent adjustment etc. allow the P&C system to be used anywhere. The open architecture allows these transactions to be combined with entrepreneurial activities. Flexibility that enables individual adjustments within the standard is part of the msg.PIA philosophy and it ensures users have extensive leeway to define their own custom rules.

Furthermore, the standard interface and remote access to business processes allow the ability to connect to customer and intermediary portals.

A diverse approach to insuring life

msg.PIA manages traditional forms of life insurance (endowment, annuity, risk tariffs, supplemental insurances), as well as unit-linked tariffs. Within that context, both single contracts, as well as joint life insurance contracts are supported. The flexible process control allows all relevant transactions performed throughout the lifecycle of a contract, such as technical changes, premium waivers, reinstatements, surrenders, death or maturity.

Integrated into msg.PIA is a standardized life insurance mathematics module that is controlled through a communication interface. Additional mathematics systems can also be connected.

Ready for international business

msg.PIA was developed for international use by insurance groups. As well as being available in numerous languages, country-specific functions are also available, whether the management of direct debit authorizations, pre-dated checks or different methods of processing returned debit memos. The management of insurance business by independent companies is enabled through the provision of separate company codes, as well as the ability to manage a variety of currencies.

The msg.PIA architecture

PRODUCT DESIGN: FLEXIBLE AND FAST

At the heart of the design is the product definition, which enables products to be quickly and easily mapped - and expanded - for all lines of insurance business. This guarantees that your portfolio always reflects the needs of your target groups. When designing the product, it is you who determines which risks should be insured and which coverages should be used to do so. The rules for taxes, surcharges/discounts, clauses, maximum/minimum premiums and premium calculations can be flexibly defined on different levels, such as contract, coverage, etc. Once defined, the rules can be immediately applied in all processes.

Intelligent modules and individualized customizing

Your company's partners only have to be registered once in msg.PIA. You can then use the corresponding "partner roles" to access your partners more quickly during day-to-day business, with roles such as policyholder, premium payer, reinsurer, intermediary, prospective customer and more. This gives you a comprehensive, 360° view of your partners.

You define your own specific sales data, commission data and production data, assemble intermediary organizations, and specify sales rights, earnings charts and cancellation reserves. A sophisticated offer system supports your intermediaries in the sale of your products. The contract module covers the creation of individual and group contracts, including the calculation of commissions and reinsurance shares. All calculations are done online. Sample contracts can be used as product templates and enable the fast creation of a contract. The efficient claims/benefit system helps you ensure the full regulation of claims and the payment of benefits.

Proportional and non-proportional participation holdings for mandatory and facultative reinsurance can be managed in the reinsurance/co-insurance module (in different currencies as well), as can open or hidden co-insurance. Non-life contract coverages can be combined with an accumulation. Distributions are undertaken automatically.

The comprehensive collection and disbursement functions and the partner settlement (premium payer, intermediary, coinsurer/reinsurer, etc.) are based on the insurance-related subledger. High-performance and flexible information systems provide detailed information on all postings in the system at any time. Posting data is transferred to the general ledger under consideration of consolidation rules and parameterizable account determination. msg.PIA offers an integrated interface to SAP-FI, although other general ledgers can also be connected.

The collection system has automated cash receipt processing and supports all forms of payment, whether payment card, SEPA or intermediary collection or even direct debits and returned debit memo processing. The flexibility and design options needed in dunning is provided through the use of dunning events, which can be easily defined when setting up the system.

Customer-specific summaries of information from the subledger and fund accounting can be found in special portals, in the Central Workplace and in the fund information; and collection functions and other business processes can be triggered from there. All while keeping the technical basis open: customer-specific requests can be mapped using add-ons, customizing and user exits.

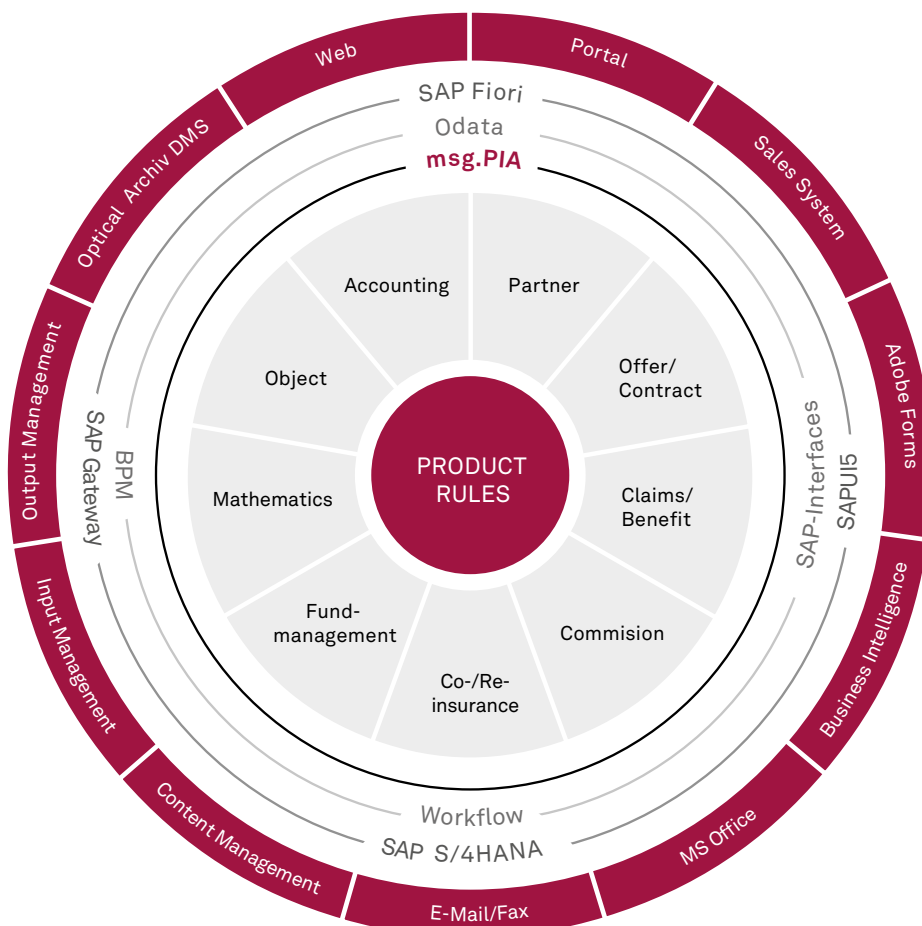
SERVICE-ORIENTED ARCHITECTURE FOR EFFICIENT PROCESSES

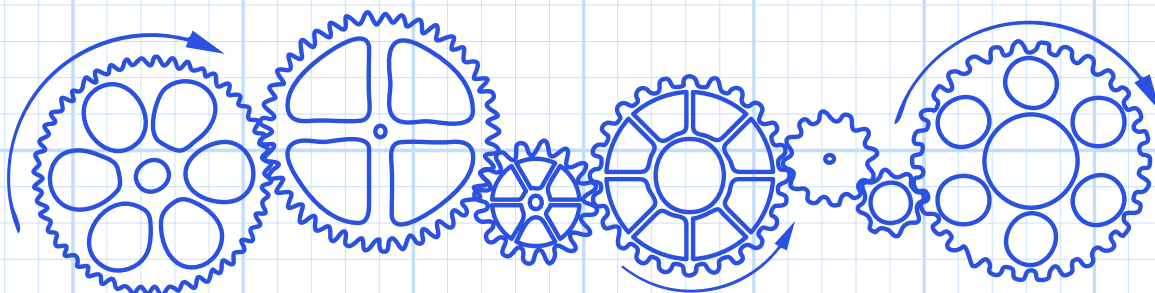
